THE CORPORATION OF THE TOWNSHIP OF MACHAR

BY-LAW NO.

Being a by-law to implement Landfill disposal fees.

WHEREAS the Municipal Act S.O.2001, c.25, s. 11(1)3. authorizes a single tier municipality to pass by-laws respecting matters within the waste management sphere of jurisdiction;

WHEREAS the Municipal Act S.O.2001, c.25, s.391(1)(a) and (c) authorizes a municipality to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it and for the use of its property including property under its control;

WHEREAS the Municipal Act S.O.2001, c.25, s.396(1)(c), (d) and (e) authorizes such a by-law to provide for fees and charges that vary on any basis the municipality or local board considers appropriate and specifies in the by-law, including the level or frequency of the service or activity provided or done, the time of day or of year the service or activity is provided and whether the class of persons paying the fee or charge are residents or non-residents of the municipality, different classes of persons and deal with each class in a different way, and the exemption, in whole or in part, of any class of persons from all or any part of the by-law;

AND WHEREAS the Corporation of the Township of Machar (the "Township") wishes to change the fees which it imposes for the use of its waste management landfill facility;

AND WHEREAS Council of the Township has determined and is satisfied that the amount of fees imposed pursuant to this by-law for the use of the Township's waste management landfill facility do not exceed the cost of providing the facility;

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF MACHAR HEREBY ENACTS AS FOLLOWS:

- 1. Waste disposal fees are hereby imposed upon those persons using the Township's waste management landfill facility in accordance with the Schedule of Fees attached hereto as Schedule "A".
- 2. All fees imposed pursuant to this by-law are payable at the facility at the time of the disposal of the waste unless prior arrangements have been made in writing with the Township permitting payment of the fees on a periodic basis when invoiced.
- 3. Interest shall be due and payable at the rate of 15% per annum on any fee imposed pursuant to this by-law that is due and unpaid.
- 4. The fees imposed by this by-law shall be effective upon Sep 1, 2021and supercede any previous fees imposed.

THIS by-law read a first, second and third time and finally enacted this 26th day of Jul 2021.

BURIED OR BURNED WASTE

(Base Formula: \$15 per cu yd uncompacted/\$60 per cu yd compacted)

Residential/Construction/Commercial/Industrial Waste (<u>Including Brush</u>)
Volumes will be determined by the Landfill Site Attendant prior to discharge

All trucks & trailers must stop at the Landfill Building

| Example: Single Axle Dump Truck | 7 yd x \$15 cu yd = \$105 |
|---------------------------------|----------------------------|
| Tandem Axle Dump Truck | 12 yd x \$15 cu yd = \$180 |
| Tri Axle Dump Truck | 20 yd x \$15 cu yd = \$300 |
| Half Ton Truck or Trailer | 3 yd x \$15 cu yd = \$45 |

Contaminated Soil \$600 per dump truck load

One Time Only Dumping by Non-Resident per bag \$10

UNSORTED LOADS WILL BE CHARGED DOUBLE FEE

| Furniture, Mattresses, Etc. | \$10 Per Item |
|---|---------------|
| Appliances & Refrigeration Units Tagged | \$5 Per Item |
| Refrigeration Appliances Untagged | \$35 Per Item |
| Air Conditioners & Water Coolers | \$20 Per Item |

Household Hazardous Waste must be deposited at the Township of Strong Landfill Site, 483 Forest Lake Rd on Hazmat dates, held bi-annually (twice a year)

Township of Machar Taxpayer Entry Card

\$20 Fee, Limit 1 Per Location \$30 Fee for Replacement Card 1st Card is Deactivated when replaced

*Non-Township of Machar Taxpayer is limited & regulated

Annual Fee per location/unit, ask Site Attendant plus Card, Disposal Fees, Recycling is Mandatory

Misuse of the card or non-payment of fees required will result in cancellation

NON TAXPAYER ENTRY FEE: \$350/YEAR
