# TOWNSHIP OF MACHAR MINUTES – REGULAR MEETING Monday, January 23, 2023

Call to Order, Disclosures of Pecuniary Interest and the General Nature Thereof; nil.

Council present: Mayor Lynda Carleton, Deputy Mayor Ron McLaren, Councillors Neil Scarlett, Pearl Ivens and Blair Flowers.

All things MPAC and Assessment related, AMCTO Advocacy Update, Calling for Return to the Assessment Cycle, supports AMO; a Call for Provincial Action on Property Assessments

Presentation given. Property values continue to be based on the market at Jan 1, 2016, there has been no reassessment in 8 years per the Province. This allowed MPAC to clear work backlog. Property values for 2022 and 2023 continue to be based on the Jan 1, 2016 valuation date. The Assessment Cycle phase in was explained (increases phased in over 4 years, decreases applied immediately). The 5 Major Factors in determining 85% of a property's assessed value are: location, lot size, quality of construction, square footage, and age of property. The real estate market has cooled a little bit, however it was noted that income levels are not keeping up with the values of properties (making housing unaffordable). Building Permits are submitted electronically every month. Appreciation was expressed to our Chief Building Official Brian Dumas. MPAC has committed to adding the appropriate value within 1 year from date of occupancy and the added assessment will be retro-active to the date of occupancy. Request for Reconsiderations were discussed with confirmation the result could be an assessment increase. Property owners are advised that if you could sell your property for the assessment indicated, then the value is correct. There's been no indication from the Province on when the assessment cycle will return.

# 5. Machar By-Law Report 2022 Year in Review, Resolution

Reviewed. Dogs and trailers are top of the list in numbers. Our Zoning By-Law permits trailers for occupancy up to 30 days in a calendar year, we don't allow permanent travel trailers. By-Law Enforcement Officer monitors the trailers and takes action once the 30 days is expired. \*There is a small number of trailers that are grandfathered (currently 8 permitted).

# 6. Shared Services Monthly Reports for Dec; Arena and Fire

Reviewed. Items provided: Fire Chief's Monthly Report Jan 2023 (chute time, Joly Fire Protection Agreement), Income Statement revenues 81.65% (Fire Response Revenue \$35,921.90 compared to \$12,500 budgeted), Expenses 83.26%, AP Ledger Dec \$8,908.56 Total. \*Commonly called "chute time" this graph shows the number of times when fire trucks, and other vehicles take longer than **two (2) minutes** to begin responding on a call. "Chute time" is measured from the time when a call is dispatched, until the time when an emergency vehicle begins continuous travel to a call.

Email indicates the condenser is a current issue at the Arena as South River tries to determine the best time for the permanent replacement. They're awaiting quotes and delivery times to determine if replacement in their annual shutdown period this year of Apr-Jun is possible. Items provided: Chief Operator Report for Dec 2022 (Condenser is starting to leak in cold weather), Income Statement revenues 80.53%, Expenses 100.32%, AP Ledger for Dec \$16,857.06 total. \*Information from Chief Operator Report for Nov 2022 indicates new units (Condenser) of that size (used Condenser) are now estimated around \$175,000. Other items due for replacement are the Chiller (2024 to meet TSSA requirements) \$150,000 and the Dehumidifier \$135,000. The Arena Ice Pad is estimated at \$1,000,000 and is over 20 years past its life expectancy. The Olympia should be replaced in 2027 and the current cost for an electric model is \$135,000. These pieces should be able to be funded by grants, if they're ever fortunate enough to get one approved.

\$175,000 at 50% capital share = \$87,500. Last year capital budgeted at \$93,829. \*Request listing.

# 7. Almaguin Climate Action; Event Jan 16, 2023 summary

Written summary provided from Al Bottomley. Councillor Scarlett provided a report on the very informative event. Misconceptions around electric cars were highlighted, 80% of lithium batteries are used for cell phones/tablets, sodium batteries are coming, operating cost is less compared to gas. It was agreed a demonstration could be co-ordinated for a Public Works meeting in Apr-May. Additionally, an event in South River (Brewery) could be co-ordinated to get information out as the Burks Falls event was not well attended by other municipalities, despite the invites sent out.
