- d) The standard conditions of provisional Consent be included in the decision as follows: the Township requires a copy of the decision, 2 copies of the registered survey, and a Cash-in-Lieu of Parkland payment in the amount of \$2,500 + HST per lot created = \$2,825. CARRIED

East Parry Sound has 2 full time vets, 1 in Sundridge and 1 in Magnetawan. Machar's fees for 2023 are the same at \$160; 10 participating municipalities fees range from \$90 - \$385.

# 11. NBPSDHU (N Bay Parry Sound District Health Unit) 2024 Municipal Levy Package

Mitigation funding from the Province has been rolled into the provincial share during the next three years, until a new funding formula for public health units is developed. Machar's share is up 3% from \$27,061 in 2023 to \$28,415 in 2024. During the next three years, the Ministry of Health's Strengthening Public Health initiative will affect public health by increasing the size and reducing the number of health units through voluntary merges, revising the Ontario Public Health Standards, and introducing a new funding formula. Municipalities will be updated on the 2023 year-end status of

the municipal reserve (nearly \$2M) following the audit process in April 2024.

#### 12. NBPSDHU Letter to Premier Intimate Partner Violence and Public Health Action

Good resolution by the Board of Health calling on the Province of Ontario and the Ministry of Children, Community and Social Services to increase the funding allocated to the Healthy Babies Healthy Children Home Visiting program that is operated out of local public health units. The program directly services individual parents who need support and the annual budget has not increased in over 10 years.
