**2022 Year End Results/Financial Information Returns**

Detailed presentation given on 2022 Audit and year end results. We received a clean Auditor's Report. Several areas finished better in 2022 than 2021, which reflects well for us post Covid. No new debt was incurred. Schedule of Tangible Capital Assets reviewed. Supplemental Municipal Information reflects the Township finished 2022 with a surplus of \$328,527. The Auditors expressed the municipality is very healthy. Auditors and Council complimented Administration staff for their work, again well done.

Administration will follow up with BLEO.

**5. Shared Services Monthly Reports for May; Arena and Fire**

The new condenser is installed at the Arena and will begin making ice. South River is still awaiting a response from NOHFC on our Stage 2 submission. Successful candidate for Part-time Arena Operator has been selected and started work. Items provided: Chief Operator Report for May 2023, AP for May \$15,765.32 Total Expenditures, Income Statement reflecting Revenues 33.90% and 26.06% Expenses, Fire Chief's Monthly Report Jun 2023, AP Ledger for May \$437,038.40 Total Expenditures, Income Statement reflecting Revenues 239.85% and 109.72% Expenses.

**a. Recreation Committee to increase Arena usage update**

South River advises it hasn't come back to their Council table to date. We've located the terms of reference drafted by South River's former Clerk, and we'll follow up with South River.

**11. N Bay Parry Sound Distr Health Unit Audited Financial Statements Dec 31, 2022**

2022 Municipal FIR Schedule 77 provided. The Health Unit has confirmation of additional funding to support Covid-19 costs for 2023 that are in excess of mandatory program funding. This means there should be no additional cost to municipalities related to Covid-19 for 2023. The mitigation funding to offset the new sharing formula with municipalities has been confirmed for 2023. For 2024, if not received, municipalities would be responsible for \$1,792,400 in additional funding.

**12. Armour Mayor Rod Ward update on MAHC Hospital Local Share**

Progress toward the overall goal of \$225 million for the Local Share has now stalled, at this point \$30-35 million below the target and even the funds committed can only be considered tentative. The original target for the entire Almaguin region was set at \$12 million over 12 years (80% or \$9.5 million toward the MAHC build and 20% or \$2.5 million for healthcare services directly in Almaguin). It was determined at the meeting on Jun 12 that MAHC will have to make a decision on moving forward on the build by mid-to-late Sep. Mayor Ward expresses we need to consider the full implications if the MAHC build does not go through. We requested to be kept updated.

**15. Eastholme Home for the Aged area rep report**

Report provided; for the past several months there has been a government funded project of \$5 million plus to replace air exchangers, windows and updating communication requirements within the building. There has been a respiratory outbreak on the 3<sup>rd</sup> floor that has required some extra restrictions for visitors. Eastholme has received funding to hire a nurse practitioner. They are no longer testing for Covid at the entrance but all visitors must wear a mask. Area rep South River Mayor Coleman can provide other updates on Eastholme in the future as required.

**16. FONOM (Federation of N ON Municipalities) need for affordable housing, ON is currently being underfunded by approximately \$490 million for housing and homelessness**
