TOWNSHIP OF MACHAR MINUTES – REGULAR MEETING Monday, March 27, 2023

6:30 pm Call to Order, Disclosures of Pecuniary Interest and the General Nature Thereof; nil.

Council present: Mayor Lynda Carleton, Deputy Mayor Ron McLaren, Councillors Pearl Ivens and Blair Flowers. Councillor Neil Scarlett was absent with notice.

Staff present: Clerk Administrator Brenda Paul and Treasurer Deputy Clerk Angela Loney. Staff scheduled to observe by teleconference: By-Law Enforcement Officer Caitlin Deevey.

Guest scheduled: Liz Bradley. Guests observing in person: John Mowat, Tamara Brash, Barb and Doug Farren, Linda McKenzie, and Faye Oei. Guests registered to observe by teleconference: Fay Boyd and Mike Mitchell, Anne and Phil Pelletier.

Presentation re Short Term Rentals, Septic Systems, Election, Fireworks

Ms. Bradley proceeded to hand deliver a By-Law Enforcement and Short Term Rental petition which she indicated was from last summer and contained 100 resident signatures. The petition is dated May 2022 and reads as follows: "Dear Mayor Carleton and Council Members,

We the undersigned, believe that the elected Council of the Township of Machar has a paramount duty to protect lake quality and the safety, security and the quiet enjoyment of its residents in the Township by enforcing the existing by-laws.

Furthermore, we believe that the issue of short-term rentals and their potential over-taxed septic systems should be addressed to prevent negative impacts on the lakes in the township.

By my signature, I am declaring that I am an eligible voter in the Township of Machar and concur with the statements of this petition."

Ms. Bradley then directed pre-registered questions related to the petition per her presentation outline and an added question to Council, summarized as follows:

"STR – Please explain Council's recent decision not to address STR."...

"Septic Systems – Please advise if addressing over taxed septic systems is a prior for this council."... "Enforcement of Existing By-Laws – How does council intend on enforcing existing by laws such as fireworks, noise and non compliance to property standards?"

"Final question – For the next election would council support telephone and online voting?"... Added question – Fireworks By-law: Canada Day, and the weekend directly before and after it.

Mayor Carleton highlighted the continuous and extensive information gathering on Short Term Rentals, information is still being received, explaining some municipalities have acted and rescinded, and listed municipalities that regulate and those that don't, expressing we've been working on Short Term Rentals and are intending on proceeding. The by-law will require confirmation that the septic system is adequately sized. Ms. Bradley submitted a Huntsville Doppler article to us titled "Huntsville STRA program has become self-sustaining: Nagy". Mayor Carleton has been in touch Huntsville Chief Building Official Christopher Nagy. It was noted that the Town of Huntsville (pop. 20,000+) won't be the same as ours, it's comparably different and much larger than the Township of Machar (pop. 2,000-).

The Clerk Administrator advised our Vote by Mail is very successful, we achieved one of the highest voter turn-outs in the Province. The Voters' List will be new next election under Election Ontario. Telephone and internet voting isn't recommended for the reasons as indicated, as well as cost, necessary infrastructure and our responsibility to ensure the integrity and results of the election. It was noted the Municipal election is the only level of government to offer the convenience of Vote by Mail.

Ms. Bradley posed a question on interpretation of the Fireworks By-Law intending fireworks only be permitted on Canada Day. Canada Day is on a Sat this year. The Fireworks By-Law indicates fireworks will be permitted on Canada Day, between 8-11 pm on Jul 1, and the weekend directly before and after it.

Ms. Bradley concluded her presentation as follows, and joined the audience: "Machar is known for good roads, and good taxes, is that going to be your legacy, is that all you're going to be good for?"

Items provided for Fire: Fire Chief's Report Mar 2023, AP Ledger for Feb 2023 \$11,390.63 Total Expenditures, Income Statement 55.62% Revenue and 4.49% Expense. Information included: Ontario Modernizing its Emergency Response System, Investment in 911 system will help emergency operators and dispatchers save more lives. Additional PSAP NG911 Transition Funding information just received. \$620,000 in funding will cover 100% of the cost transition to NG911 Dispatch. This will allow the Fire Dept to maintain self-dispatching in the digital world and not increase response times as a result of using a third party provider. Today, the alternative cost of third party dispatch service is only a few thousand dollars per year but that could change at any time. Fire Chief to be asked for presentation.

Information included: North Bay Nugget article Coun. Lowery looks for hiring freeze at city hall, Operations graph 2019 \$214,686 to 2023 \$307,818 (Machar share 2019 \$83,562

to 2023 \$173,856 per Draft 3). Additional information on Near North School Board ice request just received. NNDSB has entered into a tentative Joint Use Agreement with Strong for use of the Strong, Joly, Sundridge Arena at no cost for the use of ice time which is consistent with similar programs with the Town of Parry Sound, Township of Seguin and Town of Mattawa. At this stage of the planning the school has estimated a cost of \$3,864 for ice rental at the South River Machar Arena (38 on ice skill sessions at twice a week). This cost will be assumed by the students and for some it may be a deterrent to participating in the proposed Hockey Skills Academy program at Almaguin Highlands Secondary School for the Sep 2023 school year. South River Council will welcome a presentation and indicated they may also want to reach out to Machar. South River has indicated the cost could be significant. Machar Council is interested in a presentation if offered.

The Resolution to approve Draft 4 of the Arena Budget couldn't achieve a mover and seconder. Council discussed it for some time and then directed that Arena Budget be sent back.

The Clerk Administrator requested clarity; the Fire Budget got approval at the Shared Services meeting, and it was Arena Budget that Council were directing be sent back. Council confirmed. *The 2 shared services (Fire and Arena) proposed 2023 Budgets were in the same Resolution.
