6:30 pm By-Law Enforcement; Short Term Rentals By-Law, Resolution

Council reviewed the proposed Short-Term Rental By-Law drafted by the By-Law Enforcement Officer. There have been concerns brought forward over the last few years, and this was an election issue. Short Term Rentals have also been an issue across the Province, and Council has monitored the progress on this matter for some time. The By-Law intends to regulate Short Term Rentals to ensure the enjoyment of properties for all of our owners, ie be good neighbours, ensure the safety of visitors, adequacy of septic system, disposal of garbage, etc and is intended to be self supporting, ie the license fees will cover the costs of regulating Short Term Rentals. The proposed By-Law is available to property owners and can be requested by sending an email to the Municipal Office. Council welcomes questions and comments from property owners.

Their decision to update our operating hours was taken after much consideration of the current market environment including the competitive landscape and internal data on how our members utilize Kawartha's services across all of our branches.

3. Budget Report to Sep 30, 2023 & 2023 Tax Rate Comparison, Resolution

Revenues are at 87.95%, expenditures are at 58.63%. Councillor Pearl inquired after Eastholme reports as she had requested South River Mayor Coleman share them, as he is our regional rep. TDC advised nothing further.

Annual comparison of tax rates provided indicates on a median typical property assessed at \$216,000 annual taxes are lowest in Machar at \$2,248.58 increasing to \$2,366.02 in Strong, \$4,050.92 in Sundridge, and \$4,240.55 in South River. A higher difference of \$117.44 in Strong, \$1,802.34 in Sundridge, and \$1,991.97 in South River. Year over year percentage increases were also provided: South River = 5.8%, Strong 5.9%, Machar = 6.8%, and Sundridge = 6.8%.

The mechanical pieces will be tendered now for installation in the spring of 2024. The concrete work will require design work and project management that will be tendered this winter. Construction work will be in spring 2025. The construction work will likely require a shortened 2024/2025 winter season in order not impact Hockey Opportunity Camp. They will have better time lines after the design work is finished.

b. Arena parking lot gravel estimate update

The Village had arranged for Canor to neaten up the arena parking before they leave for the winter and at the last minute S.R. asked them how much to fix it up properly. Canor provided a quote on Fri for which they needed to know by the following Mon.
