3. Removing HST/GST from New Homes to Support Housing Affordability, Resolution

151-25 Scarlett, Ivens

WHEREAS housing affordability is one of the most pressing issues facing Ontario families;

WHEREAS the federal government recently announced GST relief for first-time homebuyers on new homes, and the Province of Ontario removed the provincial share of HST on new purpose-built housing; and

WHEREAS the current HST rate on new homes in Ontario is 13%, which adds tens of thousands of dollars to the cost of a typical home, e.g. about \$91,000 on a \$700,000 home in the Township of Machar before any existing rebates;

THEREFORE, BE IT RESOLVED THAT the Council of the Township of Machar calls on the Government of Canada to remove the GST/HST from all new homes purchased as primary residences, and to work in partnership with the Government of Ontario to ensure full elimination of the provincial portion as well; and

BE IT FURTHER RESOLVED THAT this resolution be circulated to the Prime Minister of Canada, Minister of Finance and the Minister of Housing, Infrastructure and Communities; and to the Premier of Ontario, the Ontario Minister of Housing, our local MP and MPP, and the Association of Municipalities of Ontario. CARRIED

Fire Chief Draft Letter, Resolution

153-25 Scarlett, McLaren

WHEREAS Ontario Regulation 343/22 mandates that firefighters performing specific fire protection services be certified to a prescribed standard by July 1, 2026, with certain technical rescue disciplines requiring certification by July 1, 2028;

AND WHEREAS many fire departments in Ontario are staffed predominantly by volunteer firefighters who balance full-time employment with their emergency service commitments;

AND WHEREAS the certification programs are still under development, and current availability does not adequately reflect the operational realities of volunteer fire departments—particularly in rural communities—where training opportunities are limited and certification demands place undue pressure on personnel and municipal resources;

AND WHEREAS existing training programs and established level of service are designed to meet the needs identified in the current Community Risk Assessment and ensure the continued safety of the community;

AND WHEREAS it is unreasonable to expect volunteer firefighters—who already balance full-time employment and community service—to independently develop curriculums and in-house training programs that meet provincial standards and adequately prepare them for certification exams;

AND WHEREAS these mandatory certification requirements pose significant challenges for small, rural, and northern municipalities due to limited financial and training resources, geographic barriers, and reliance on volunteer fire departments;

AND WHEREAS the implementation of these requirements, without additional flexibility or provincial support, may negatively impact the Township's ability to recruit and retain volunteer firefighters and to provide adequate fire protection services to its residents;

NOW THEREFORE BE IT RESOLVED THAT Council for the Corporation of the Township of Machar formally opposes the mandatory firefighter certification requirements as currently outlined in Ontario Regulation 343/22;

AND BE IT FURTHER RESOLVED THAT a copy of this resolution be forwarded to the Honourable Premier of Ontario, the Minister of the Solicitor General, the Ontario Fire Marshal, the Association of Municipalities of Ontario (AMO), and all neighbouring municipalities for their support. CARRIED
