PUBLIC MEETING

6:30-6:45 pm Zoning By-Law Amendment 1-192-12, Staff Report, Resolution

Mayor Carleton welcomed everyone in attendance to this Public Meeting, held under Sections 17, 22 and 34 of the Planning Act, Notice was provided in accordance with the requirements of the Planning Act. Mayor Carleton explained the process of how the Public Meeting was going to go and how comments were going to proceed after. Mayor Carleton gave Jamie Robinson from MHBC Planning, the Township's Planning Consultant, the floor to provide an overview of the application process then the Applicant to provide an overview of the application. Mayor then took comments from the Public. The subject lands is located within the area that is designated as Rural in the Official Plan. As indicated in the application submission, the proposed development includes the following: The application seeks to facilitate the development of a Tourist Commercial use, consisting of six geodesic dome structures to be used for overnight accommodations, an accessory dwelling unit, and a hobby farm. The proposed use on the subject property generally meets the definition of a tourist establishment in the Zoning By-Law, and this use is not permitted within the RU Zone and therefore an amendment to the Zoning By-Law is required. Mayor Carleton opened the floor to the Public for comment. Several in attendance expressed their opposition. Risks of forest fire, renter oversight, traffic, and noise were some concerns. Mayor then provided Council with the opportunity to ask questions for clarification. Decision deferred, comments will be forwarded to our planner for review and report back. Parties attending tonight will be apprised when Council will consider the further report and decision.

Mayor Carleton gave Jamie Robinson from MHBC Planning, the Township's Planning Consultant, the floor to provided an overview of the application. It is recommended the proposed Severed Lot is rezoned to the Rural (RU) Zone to reflect the residential use of the property. The minimum lot area for the RU Zone is 1 hectare and the minimum lot frontage is 90 metres, for single detached dwellings. The proposed lot area is .05 hectares and the proposed lot frontage is 60 metres. A Zoning By-law

Amendment is recommended as a condition of provisional Consent to ensure that the proposed Severed Lot complies with the Zoning By-law.

- That the Applicant for Consent (to sever 1 new lot) on the subject lands located as described above be provisionally approved, subject to conditions listed in the report, including but not limited to:
- a) That the applicant meet all financial requirements of the Municipality.
- b) That a registrable description of the Severed Lot be submitted to the Municipality.
- c) Confirmation from the North Bay Mattawa Conservation Authority (NBMCA) that the proposed Severed Lot can be adequately serviced by individual on-site septic system.
- d) Confirmation from a licensed Sewage Disposal Business that they have the ability to accommodate hauled Sewage from the one additional lot.
- e) That a draft survey of the Severed Lot be provided to the Township for review and approval.
- f) That the applicant obtain approval for a Zoning By-law Amendment to rezone the proposed Severed Lot to the Rural (RU) Zone and to permit the reduced lot area and lot frontage.
- g) That the applicant obtain an entrance permit from the Township for the proposed Severed Lot.
- h) The standard conditions of provisional Consent be included in the decision as follows: the Township requires a copy of the decision, 2 copies of the registered survey, and a Cash-in-Lieu of Parkland payment in the amount of \$2,500 + HST per lot created = \$2,825. CARRIED

Submitted with payment of fee and deposit towards costs but without required neighbour consents due to Estate/Trustee oversight and out of country owners. Applicant has demonstrated communication attempt and proposed a two-metre setback from both the abutting property owner's boundary lines. Mayor suggested Admin contact the out of country abutting property owner with the Notice once it's prepared. To further advocate for the property with limited lakeshore allowance, Council would appreciate a measurement of 10 metres instead of 2 metres from the southern neighbour's boundary line, in consideration of their future shoreline usage.
